MAKE48 COMPETITION

There have been mixed reviews from the boat builder organizations regarding moving forward with investing in a regional make48.com competition. Mostly, it is seen as a great opportunity for company exposure with high school and college students, with a minimal investment of \$2,500 by each organization. Jeff Frank shared that FMG would participate for the company exposure, as there would likely not be a direct benefit. If one of the three boat builders is unable to participate, Ann shared the NCMMA could sponsor in their place.

There was a question related to who owns the intellectual property (IP). After the meeting, Ann learned that investment of \$25,000 is required for the company to own the IP. However, Make48 would modify their rules and give the marine builder the IP at the \$10,000 sponsorship level, as long as the students/educator would be financially compensated.

Josh Delforge will be presenting the idea to his colleagues tomorrow and will follow-up with Ann and the other boat builder members.

FALL 2025 ASSOCIATE MEMBER MEETING

September 9, 2025 is the tentative date for the fall associate member meeting at Burger Boat Company. Breakfast will be served starting at 8:00 a.m., followed by the program from 8:30 to 10:30 a.m. Each boat builder organization will provide an update, followed by a brief company overview by each of the associate member organizations.
